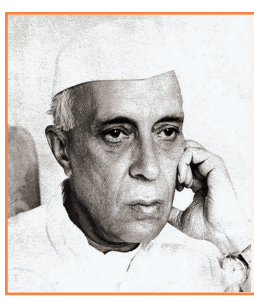

An interview with Prof. Rajiv Bhat, Director of Admissions



Lakshmi: How do you find this new experience with another side of the University, as part of the administration?

Rajiv Bhat: Even as a faculty member of a Centre or a School one deals with a lot of administrative work besides teaching and research responsibilities but most of it pertains to the functioning of the School/Centre. I have been earlier involved in several administrative works within the School of Biotechnology since early 1990 during its earlier phase of development and was recently the Dean of the School during 2009-11. As Director of admissions, one gets the opportunity to understand and appreciate the larger canvas of JNU with its broader challenges as well as opportunities for improvement. The administrative responsibility also opens up doors for interaction with students, faculty, Chairpersons and Deans across various academic programmes in JNU and to address their concerns related to the admission process. I have always appreciated the dedication of the staff of the Admissions branch steered by Coordinator (Evaluation) in successfully conducting entrance examination across the country year after year, declaring results in time, and admitting students in time. This makes my job as Director of Admissions easier and allows for looking into other important policy issues related to admissions.

Lakshmi: As Director of Admissions, what duties fall to you?

Rajiv Bhat: Director of Admissions position was created in JNU more than a decade ago when it was felt that there is need to have a greater liaison between Admissions office controlled by the Coordinator(Evaluation) on one hand and the Deans/Chairpersons of Schools/Centres as well as Rector and VC on the other hand. The prime responsibilities are especially to look at the Admission process as a whole and to facilitate the implementation of the admission policy from time to time as guided by various statutory bodies of JNU. The main job is to reach out to the several corners of the country in order to attract applications from far and wide, conduct entrance examination with all meticulousness and confidentiality that it needs, and finally to maximize the admission of students as per

requirements and to implement the reservation policies of the Government. In nutshell, the admission process would be deemed successful if one is able to attract quality students with the desired numbers that we intend to take and can accommodate from time to time.

All this throws up a lot of challenges every now and then and calls for mid- term reviews and corrective measures. This is primarily taken care of by the Standing Committee on Admissions appointed by the Academic Council to look at aspects of the admissions process of a particular year, to analyze trends in the admission over the last few years and to recommend measures to be adopted in the following years to the Academic council for broader discussions and implementation.

Lakshmi: You talked about examining trends in the flow of students. Can you tell us more about what you've noticed? And how do you deal with these patterns?

Rajiv Bhat: First, as I mentioned earlier, we need to maximize admission in the University in general and programme-wise in particular based on the intake capacity every year. Since the University admission policy does not provide for a wait-list, in order to achieve optimized enrollment each School/Centre is requested to indicate the number of offers to be made every year which are usually slightly higher than the intake capacity based on previous years' experience of each programme in terms of shortfall in admission during earlier years, if any. Hence, the number of offers are tuned every year based on the past experiences and approved by the Academic Council well in advance.

When the results are announced and the last date of admissions, e.g. 5th August this year, is over, the Standing Committee on Admissions takes a stock of the enrollment collectively in the university, programme-wise, as well as reservation-related admission. As per Academic council decision, only for those programmes, where in the admission falls short of 50% of intake, a second list may be announced. However, in case there are several programmes where such a situation arises leading to an overall larger shortfall, the Standing Committee is authorized to take decision every year

to enhance this cut-off for the second list. For example, this year by consensus, this percentage for the second list was increased to 70%. This enabled to fill additional seats as part of the second list. Despite all these efforts, still some seats were left vacant and one needs to look into these aspects and take care of this for admissions next year. Standing Committee on Admissions is meeting soon to discuss these issues.

Lakshmi: When drafting policies for intake as you mentioned, are there any models you follow from other universities?

Rajiv Bhat: JNU in its self is a unique model as we deal with conducting exams at 80 centres across 52 cities in the country including one in Kathmandu with 120 programmes of study. In addition, on behalf of 40 participating Universities, JNU conducts an All India Combined Entrance Examination in Biotechnology for M.Sc., M.Tech., and M.V.Sc. programmes including M.Sc. Biotechnology at JNU. It has been possible to efficiently conduct this gigantic task with only the active participation of JNU faculty, staff, and the untiring efforts of the Admissions branch.

In order to attract students from various not so developed regions of the country and some other categories, deprivation points of 5 and 3 marks are given to students belonging to

several such districts classified as Quartile 1 and 2, respectively. To promote having a desirable gender ratio in admissions, 5 marks are given to female candidates. Recently this ratio has almost become unity and the requirement needs to be looked into further. All put together, it is a mammoth task and, thus, unique among the University system in the country. Hence, any challenges in fulfilling the intake of the students have to be dealt with in-house strategies with a consultative mechanism in place.

Lakshmi: I'm sure that being in a position to observe the intake of students from above will give you an interesting view of the cross-section of the campus population.

Rajiv Bhat: JNU truly is a microcosm of the country and with a large size of foreign students coming from several countries, it indeed is a set-up which throws up diverse challenges but at the same time provides for immense opportunities both for the students as well as the faculty. With the student population having increased considerably over the last few years on one hand and several faculty members having retired in the period, JNU is poised with challenges to recruit quality faculty as well as to build infrastructure at a rapid pace in order to maintain the pace of excellence as we move ahead.

◆ **Prof. Akhtar Mahdi**, Centre for Persian and Central Asian Studies, School of Language, Literature and Culture Studies has been awarded a Plaque of Appreciation by the University of Tehran, in recognition of his life long service for the promotion of the Persian Language and Literature and also the development of Iranian Culture in Indian sub-continent.



◆ **Prof. B. R. Deepak**, Centre of Chinese and Southeast Asian Studies, School of Language, Literature and Culture Studies, has won the "Distinguished Book Award of China" for the year 2011, for his book 'Chinese Poetry : 11th Century BC to 14th Century'. He is the first Indian to receive this award. The book is the first of its kind consisting of translation and annotation of 88 poems selected from various poetic periods of the Chinese history starting from Shijing of preQin to Xixiangji of the Yuandynasty.

He was also presented with a Hat of Wisdom, a Sword of Truth and a Diploma by Professor Seppo Hentila, the Conferrer of the Honorary Doctorate.



◆ **Prof. Balveer Arora**, former Rector and Professor, Centre for Political Studies, School of Social Sciences, has been recently made a Knight in the Order of the Legion of Honour (Chevalier dans l'Ordre de la Legion d'honneur) by the French Republic. A Memorandum of Understanding between Jawaharlal Nehru University and Exim Bank of India for the Maintenance and Development of the Exim Bank of India JNU Economics Library was signed between the Vice-Chancellor, JNU and the Chairperson, Exim Bank, in JNU. Both resolved to continue their cooperation for the purpose of making the Exim Bank of India JNU Economics Library (the Library) an Economics library of excellence.

Under this Memorandum of Understanding Exim Bank shall provide 12.5 lakhs per annum, for a period of five years, commencing from April 1, 2011. Of this, Rs. 10.40 lakhs would be earmarked each year for purpose of acquisition of books and journals for the library; Rs. 4.00 lakhs each for two seminars to be organized during the period of MoU in JNU, with CESP-JNU taking the primary responsibility of organizing the seminar in consultation with Exim Bank; and Rs. 50,000/- would be earmarked each for incidentals/contingency.

Single-Window System introduced to streamline Admissions

The University administration introduced a single-window system for admissions this year, making the admission process less cumbersome. Earlier the students had to go through the lengthy procedure of filling 12 forms, which has been reduced to four this year.

The purpose was to make registration and the admission process less time-consuming. All the information related to the shortlisted candidates was in the university database. When the students came for admission, they had to fill four forms,

including the one for hostel accommodation. After submitting three forms at the admission office, candidates went to their respective schools/centres. At the schools/centres, applications were downloaded, final registration was done and the admission process completed.

The administration is planning to make the application process online from next year. The students will not only get their results online, but they will also have fill up the registration forms online, before coming for the final admission.

"The Sustainable Development of Indian Rivers: From Science to Society"

The School of Environmental Sciences organized a one day seminar on 13 June, 2011 in SES on "The Sustainable Development of Indian Rivers: From Science to Society". The objective of this seminar was to get a broad overview of the subject and discuss future directions of interdisciplinary

research in River Science. The meeting was attended by Prof S. K. Sopory, Vice Chancellor JNU, Prof Sudha Pai, Rector, JNU, and faculty and students of the university. The eminent persons who delivered lectures included Prof S. K. Tandon (internationally acclaimed geological scientist, and former Pro VC, DU), Sh.

Ramaswamy R Iyer (renowned water-policy expert and currently visiting fellow at Centre for Policy Research), Dr. Manohar Arora (Senior Scientist at the National Institute of Hydrology, Roorkee) and Shri Rajendra Singh (Magsaysay Awardee and well-known water conversationalist).

In his opening remarks, Prof Sopory appreciated the initiative of SES to organize the seminar on an issue of national importance. He also urged that such seminars should be held periodically and JNU, SES in particular, should work towards a policy draft for consideration by Indian Govt. Prof. Tandon in his talk on 'River Science for River Futures' shared the existing scientific knowledge about Indian rivers and highlighted the need of research at various levels to protect Indian rivers. He discussed the basic tenet of river science which states that it is important to respect the inherent diversity, complexity, and variability of river systems. This however cannot be done in a reductionist discipline-specific mode. Mr. Aiyer spoke on 'Wrong and Right Thinking About Rivers' and shared his vast experiences on how Indian rivers became polluted with time. He also discussed Govt. policies and gave his own opinions on the issue of water conservation and river sustenance. He concluded that "Let the rivers live, Let us learn to live with rivers and Let us forget Prometheus and remember Bhagiratha". Dr. Arora delivered a lecture on "Base flow in rivers and their impact on Environment" in which he discussed the existing knowledge about the hydrological observations and techniques applied to monitor the water status. Shri Singh in his talk on "Need of National River Policy" appraised the

audience about his past experiences on water conservation, status of Indian rivers and his ongoing involvement in drafting the national river policy. He also urged the scientific fraternity to give their inputs so that a comprehensive draft on the river policy could emerge for consideration by the Govt.

The lectures were followed by a lively discussion chaired by Prof. A.L. Ramanathan (SES) in which Prof. B.S. Chmni (SIS), Prof. R.P. Sengupta (SSS), Prof. A.K. Attri (SES) amongst other JNU faculty and students, put forward their views. Mr. Shankar Mahto, Chairman, Brahmaputra Board, Ministry of Water Resources, Govt. of India, gave the Government's perspective and discussed his experiences of river water conservation.

The meeting was organized by Prof Sudha Bhattacharya, Dean SES assisted by Prof AL Ramanathan and Dr Sudesh Yadav.

The concluding message from the meeting was that rivers must be recognized as natural entities in their own right, whose existence on our planet is not merely to serve the needs of the human species. Hence knowledge of the river from its geological and ecological perspective must be borne in mind before channelizing this precious fresh water resource for societal needs. JNU faculty with their combined expertise in relevant disciplines can make a unique contribution in furthering these perspectives.

“हिंदी साहित्य की दुनिया बहुत बड़ी है”— तेजी साकाता

“भक्ति साहित्य सिर्फ हिंदी या हिन्दुस्तान का साहित्य नहीं है, बल्कि यह मानवता का साहित्य है। इंसानियत के साथ उसका गहरा रिश्ता है। उसे पढ़ने और समझने का अर्थ है, मानव और उसके सभ्यता के इतिहास को जानना !” ये बातें हिंदी के प्रसिद्ध जापानी विद्वान प्रो तेजी साकाता ने भारतीय भाषा केंद्र द्वारा ‘भक्ति के अर्थ’ पर आयोजित व्याख्यान में कही। प्रो. साकाता आजकल जापान के ताकुशाकु विश्वविद्यालय, तोक्यो में हिंदी के प्रोफेसर हैं और शोध के सिलसिले में प्रतिवर्ष भारत आते रहते हैं। उन्होंने कहा कि “हिंदी साहित्य की दुनिया बहुत बड़ी है। भारत और जापान का धार्मिक जीवन एक जैसी परंपराओं से प्रभावित है। हम बुद्ध को भी मानते हैं और कृष्ण को भी। इनके बारे में लिखा गया साहित्य जीवन को समझने में मदद करता है। ये हमारी दुनिया और हमारे अंदर मौजूद मानवीय भक्ति की चेतना को बढ़ाते हैं।” उन्होंने यह भी बताया कि जापान में भी भक्ति साहित्य से मिलता-जुलता साहित्य है और वहाँ के लोग भी इस साहित्य को पढ़ने में दिलचस्पी ले रहे हैं।

भारतीय भाषा केंद्र की ओर से आयोजित इस व्याख्यान में प्रो. साकाता की बातचीत को आगे बढ़ाते हुए ताशकंद के प्राच्य विद्या

संस्थान से आयी डॉ. उल्फत मुहिबा ने हिंदी के वार्ता साहित्य में 'चौरासी वैष्णवन की वार्ता' का उल्लेख किया और कहा कि "भक्ति का अर्थ केवल भगवान की भक्ति नहीं है, भक्ति का अर्थ बहुत ही व्यापक है और उस काल के सभी कवियों के यहाँ भक्ति का अर्थ अलग-अलग है। जैसे – मलूकदास के लिए भक्ति का अर्थ था – लोगों की सेवा करना। सभी लोगों के बीच प्रेम, समानता का भाव पैदा करना ही भक्ति साहित्य का प्राथमिक लक्ष्य था।"

अतिथि वक्ताओं के व्याख्यान के बाद दोनों विद्वानों ने छात्रों के विचारोत्तेजक सवालों का जवाब भी दिया। कार्यक्रम की शुरुआत में

डॉ. देवेन्द्र चौबे ने अतिथियों का स्वागत करते हुए कहा कि भक्ति को केवल धर्म से नहीं जोड़ा जाना चाहिए। भक्ति मुक्ति देता है, आगे बढ़ने का मार्ग खोलता है। कार्यक्रम के अन्त में एम.फिल. हिंदी की शोधछात्रा शीला आर्य ने केंद्र के छात्रों की तरफ से अतिथियों का धन्यवाद ज्ञापन किया।

Lectures in School of Arts & Aesthetics

- A Lecture on "The Shadow of "Authenticity": Museums, Temples and the Display of Religious Icons" by Prof. John Cort, Professor and Director of the Department of Religion, Denison University was organized on 5 August, 2011. Dr John Cort is an eminent scholar of Indian religion whose distinguished work has focussed on the place of temples, icons, texts and traditions in Jainism. His recent book, "Framing the Jinas: Narratives of Icons and Idols in Jain History" (New York, OUP, 2010) discusses Jain discourses and practices concerning temple images.

In this talk, Dr Cort addressed the issues that arise when objects made for temple contexts move into the museum. How should such objects be displayed? What do they gain, and what do they lose, if they are presented as autonomous aesthetic objects? Conversely, if they are contextualised as ritual objects, does this deny them the right to be art? Taking up issues and specific instances, Dr Cort's seminar with issues of 'authenticity,' meaning, and value ascribed to art in shifting institutional locations.

- A Lecture on "Indian Visual Culture as World Commodity" by Professor Frederick Asher, Department of Art History, University of Minnesota was organized on 12 August, 2011. Dr Frederick (Rick) Asher is a major figure in the study of Indian art history. Known for his important early work on Gupta and Pala period art, his current research considers the architecture of contested religious space, issues related to art as commodity and patterns of trade.

In this talk he discussed the role and presence of classical Indian art beyond India, that is, Indian visual culture as part of a world system. He argued that much as India borrowed visual ideas from distant parts of the world and, it exported ideas across the world to areas with which India was and remains connected, though in diverse ways through time.

Following the work of Janet Abu-Lughod, who argues that India was central to a world system long before the age of European colonialism, as Immanuel Wallerstein had argued, Asher extended that notion even further back in time, to the time of Aśoka, as well as forward to the present day. The various factors that stimulate the transmission of visual ideas which were discussed in this lecture included: Appropriation of the Other, pilgrimage, trade in luxury goods, war, colonialism, and diasporas.

- A Lecture on "Masculinity, ethnicity and sexuality" by Girish Shahane, a prominent art critic and commentator on cultural matters, was organized on 26 August, 2011. Girish Shahane is a columnist for Yahoo India and a former editor of Art India Magazine, he is a freelance writer based in Mumbai, who administers the prestigious Skoda Prize for Contemporary Indian Art. Shahane is the curator of the upcoming exhibition Home, the Devi Art Foundation. Among the places he has lectured or presented papers are NCPA and NGMA in Mumbai; Max Mueller Bhavan, Bangalore; India School of Business, Hyderabad; Tate Modern, London; Wesleyan University, Middletown; and the Art Institute of Chicago.

In this lecture he compared depictions of Indian men and accounts of masculinity in the subcontinent with representations of European and African maleness. Through the comparison, his talk revealed deficiencies in the currently dominant academic viewpoint which considers masculinity purely a social construct. The talk drew on a wide range of examples from art, literature, advertising, cinema and cricket in making an argument against postcolonial theory.

समारोह के आरंभ में प्रो. कृष्णस्वामी नाचीमुथु ने अतिथि महोदया डॉ. सुशीला टाकभौरे का स्वागत किया। स्वागत कार्यक्रम के बाद एम.फिल. हिन्दी की छात्रा प्रियंका सोनकर ने सुशीला जी की एक कविता का काव्य पाठ किया। काव्य पाठ के बाद दलित प्रभारी डॉ. रामचन्द्र ने हिन्दी दलित साहित्य में सुशीला टाकभौरे के महत्व पर

English for Linguistic Empowerment

"Basic Communication Skills- Level -1" and "English for Academic Writing- Level 1", two courses meant for linguistic empowerment of the students from across the schools and centres of JNU, have been introduced by the university this semester. The Vice Chancellor Prof S.K. Sopory inaugurated the programme on the 19 August 2011 in the auditorium of the SSS. The meeting was chaired by the Rector, Prof Sudha Pai who explained how the three units meant for capacity building of JNU students, namely Equal Opportunity Office, Language Cell and Disability Cell were brought together by the Vice Chancellor, to work together in an integrated manner.

Professor Vaishna Narang, Convener of the program, explained in her welcome address and introduction to the

program how the erstwhile Centre for Linguistics and English, and later Prof GJV Prasad from Centre for English Studies and she from Centre for Linguistic, struggled for setting up a language cell which would serve the purpose of linguistic and cognitive empowerment of JNU students. She explained the need to have such foundation courses in place of the so called Remedial English courses running for more than three decades.

She said that 250 students had registered for the Basic Communication Skills, and more than 275 students registered for the English for Academic Writing course. The English Language Cell had become a reality thanks to the vision and the

support of the Vice Chancellor, Prof S.K.Sopory and the Rector Prof Sudha Pai.

Dwelling upon questions like what is linguistic empowerment, and what can we do to empower ourselves, why language is important for us, she explained why such language courses are absolutely essential for any academic program conducted by institutions of higher learning in India. She identified the most important reason to be the state of language education in India, which at any and every level is a national embarrassment. Educationists have forgotten that language is a means to cognition as well as a product of human cognition. Learning languages enriches, enhances cognition. Educationists fail to recognize the fact that the failure of education system, especially at the primary level can sometimes be entirely attributed to the failure of language education. Our education system, just like the rest of the modern world which has become a global village has blindly supported science and technology, engineering and management and commerce etc. without understanding that language education which is so very necessary for the cognitive development and enrichment of the learners.

Prof RN Menon, Dean SLL&CS, in his address to the students explained the role and strengths of the School of Language, Literature and Culture Studies in the university, while Prof Sonajharia Minz, Chief Advisor, EOO highlighted the activities of the EOO in capacity buildup programs. Prof Karmeshu, Dean SC&SS, announced two special introductory courses in computers for the new entrants of JNU. He mentioned that Prof GJV Prasad, who was one of the moving forces for this programme, could not be present at the function because of personal reasons.

On this occasion, Prof Harish Narang, special invitee, who retired from CES and was UGC Emeritus Fellow in SLL&CS, who has had the long association with the English language programs including those for the foreign students and the Remedial English programme for our Indian students, told success stories of JNU students from his four decades of

experience of language & literature programs in JNU. He emphasized that these success stories were there only because of a very high level of motivation of the students who came from remote rural areas of the country and went on to become Professors in different universities of the country or went to other successful careers with a special mention of two alumni of JNU, Prof Bhonsale from Bombay University, and Moola Ram teaching English in a college in the University of Delhi.

The Vice Chancellor, Prof S K Sopory, inaugurating the program emphasized that it is absolutely essential to have a good command over English to be able to understand the discipline that you want to pursue and to express your research, your ideas, to the rest of the world. He explained how he planned to create different units for capacity buildup and empowerment of the student community. In fact, the three units -Equal Opportunity Office, Disability Cell and English Language Cell, and also the fourth one announced by the Dean, SC&SS, to offer basic computer courses for the students of JNU work together as a team towards a common goal of capacity building and empowerment of the student community in JNU. Four well-qualified and experienced teachers were engaged as Guest Faculty to take up this responsibility in English. Since our students come from all over India, including many from rural areas in the remote parts of the country, where they had no exposure to the language, it was very necessary for them to prepare themselves for receiving the education imparted in JNU, and for conducting their research eventually. Wishing the students the very best, Prof Sopory also announced that the students would get a certificate of proficiency after successful completion of the Level 1 courses this semester and Level 2 courses in the following semester.

The program ended with a vote of thanks by Prof Vaishna Narang.

Seventh J.P. Naik Memorial Lecture

The Educational Records Research Unit (ERRU) organised the Seventh J.P. Naik Memorial Lecture, an annual feature since 2005, to commemorate the death anniversary of eminent educationist J.P. Naik, who founded ERRU in 1971. The Memorial Lecture was delivered by Professor Mrinal Miri, Chairman, Centre for the Study of Developing Societies, on 26

August 2011, in the Committee Room of SSS-I. The session was chaired by Professor S.K. Sopory, Vice-Chancellor and attended by a large audience of scholars.

The topic addressed by Professor Miri was 'Higher Education: Autonomy, Responsibility and Challenges'. He said that there is

no doubt that education has an instrumental value. But that is not the only kind of value it has. It has a value that is specific or internal to it. The specific value of education consists in its inherent capacity to enhance the human person. It is interesting that this value of education is intimately connected with the values that we have, as a nation, committed ourselves to. These are values such as: a democratic way of life (freedom of speech and expression as cognates of this value), economic progress with one eye firmly on the principle of equity, equality of races, castes and genders, secularism based not on rejection of, but respect for all religions, respect for cultural and linguistic plurality and diversity of traditions, communities as sustaining different forms or ways of being human.

Professor Miri further observed that the internal value of education demands that the practice of education be

autonomous, and the autonomy of the practice of education, in its turn, demands that institutions that sustain such practices be autonomous. The notions of autonomy, responsiveness and responsibility are necessarily connected. He ended the lecture by mentioning, rather randomly, three challenges for higher education in our country: the challenge of interdisciplinarity, of the great diversity of languages and cultures, and of research.

Seeing special interest of the audience on the issues raised by Professor Miri, the lecture was unconventionally opened for discussion. Professor Sopory initiated the discussion by his observations as part of chairperson's remarks.

Book Review

The Story-Time of the British Empire Colonial and Postcolonial Folkloristics

An analysis of the folklore collected by imperials and colonials during the second empire

In "The Story-Time of the British Empire", author Sadhana Naithani examines folklore collections compiled by British colonial administrators, military men, missionaries, and women in the British colonies of Africa, Asia, and Australia between 1860 and 1950. Much of this work was accomplished in the context of colonial relations and done by non-folklorists, yet these oral narratives and poetic expressions of non-Europeans were transcribed, translated, published, and discussed internationally. Naithani analyzes the role of folklore scholarship in the construction of colonial cultural politics as well as in the conception of international folklore studies.

Since most folklore scholarship and cultural history focuses exclusively on specific nations, there is little study of cross-

cultural phenomena about empire and/or postcoloniality. Naithani argues that connecting cultural histories, especially in relation to previously colonized countries, is essential to understanding those countries' folklore, as these folk traditions result from both internal and European influence. The author also makes clear the role folklore and its study played in shaping intercultural perceptions that continue to exist in the academic and popular realms today. "The Story-Time of the British Empire" is a bold argument for a twenty-first-century vision of folklore studies that is international in scope and that understands folklore as a transnational entity.

Release of IERB for Research on Human Subjects: Information and Guidelines- 2011

The first brochure of the (IERB-JNU) was released by the Vice Chancellor, JNU on 26 May 2011, in the 8th meeting of the Board. "The Institutional Ethics Review Board" was originally constituted by the Executive Council of JNU vide its resolution no.EC/ 5.3/3.9.2008 with Prof. RNK Bamezai as Chairperson and Prof. Vaishna Narang as Member Secretary. The board reviews research proposals which may involve participation of human beings as subjects, submitted by the faculty and students of JNU for ethical clearance.

The board was reconstituted recently with 20 new members and 16 members continuing for another term as per EC resolution no. 6.22/5th April 2011 with Prof. Shiv K. Sarin as the new Chairperson. Dr. Shiv K. Sarin an eminent medical scientist, former Chairperson of MCI, is currently the Director, Institute of Liver and Biliary Sciences, Vasant Kunj New Delhi.

On 26 May 2011, in the first meeting of the new board, Prof. S.K. Sopory welcomed the new chairperson and the new members, and released the brochure titled "Institutional Ethics Review Board for Research on Human and Guidelines- 2011", IERB-JNU. In his message Prof. Sopory said I am very happy with the establishment of an Institutional Ethics Review Board (IERB) at JNU. The basic responsibility of an institutional ethics committee is to ensure a competent review of all ethical aspects of the project proposals received by it in an objective manner and to provide advice to researchers on all aspects of the welfare and safety of the research participants after ensuring the scientific soundness of the proposed research through appropriate review Committee. I am sure the IERB-JNU will not only look in to initial proposals prior to institution of the projects but will also have a continuing responsibility of regular monitoring of the approved programs to foresee compliance of the ethics as per guidelines during the period of the project/research work.

Further, IERB should also organize awareness workshops to bring out the scope, aims and principles of legislation, politics or other instruments in the field of bioethics."

Prof. Shiv. K. Sarin in his message emphasized that "the broad principles of research should be that the benefits of research should be far reaching and without any harm to the individual. With the emergence of the new disciplines like organ transplantation, stem cell biology, regenerative medicine, human genetics, proteomics, bio-devices, clinical trials, etc.; the scope and responsibilities of the ethics committees have enormously increased.

I am delighted that the EC at the JNU have experts with significant knowledge domains in various disciplines of science and public life. With the help of these eminent members, we do hope to provide fair, independent, comprehensive and timely review of the ethics of the proposed studies. I do believe that we would be able to have a good feed back on the science generated at the completion of the research studies at this prestigious university."

The brochure contains besides the information on how to apply and the prescribed format for the informed consent, excerpts from ICMR guidelines, UNESCO guidelines and WHO guidelines. It also contains the full text of SOP's (Standard Operating Principles) as adopted by the IERB-JNU on 20-01-2010. While introducing the brochure Prof. Narang, put on record a vote of appreciation and thanks for Prof. Bamezai, the first Chairperson of IERB under whose leadership, a lot of effort and time was spent in setting up the IERB-JNU and evolving SOP's for IERB.

Alumni Corner

An interview with Siddhartha Gigoo, Assistant General Manager, Technical Communication, Tata Consultancy Services Limited, New Delhi



Wafa: When and how did your association with JNU begin? What were your first impressions about this University?

Siddhartha: I joined the Center for

Linguistics and English at JNU in 1997. I was quite surprised to see my name in the list of selected candidates, since I hadn't really performed too well in the entrance examination, or so I thought. Initially, I was excited at my selection, but as classes began, the excitement turned into disillusionment. I became conscious of my inadequacies as a student.

The courses were unconventional, as were the pedagogical methods of teaching. I came from a small town and had never been to a college (I had done my graduation in English Literature as a private student). Attending classes, participating in classroom debates, presenting seminars and term papers - I was not prepared for it. Lack of preparedness and disinterest led to poor grades. Yet, somehow I trudged on from one semester to another.

Those were terrible times for me. I struggled with my studies. Good grades evaded me. Failure stared me in my face and the world mocked me. I slept during the days and idled during the nights. I laboured from one text book to another, sometimes seeking enjoyment and sometimes to broaden my experience and understanding of life and the world.

The first impression was one of shock and awe. Culture shock, perhaps! Having been a loner for years, it was difficult to adapt to the vibrant life in the campus. It was fashionable to question notions, theorise and intellectualise.

Room Number 13, Jhelum Hostel was my address for those two years. I made new friends and many of them inspired me in different ways. They introduced me to world literature and cinema. Chatting with friends at Ganga Dhaba and Parthasarathi rocks became a favourite past-time.

Wafa: How has JNU shaped your perception in relation to your profession? Do you think JNUites do things differently in your field?

Siddhartha: I tasted failure there - academically. Became aware of my imperfections. Questioned the very purpose and essence of my being and looked upon myself with profound suspicion. And gradually developed a philosophical bent of mind! Learnt to laugh at things! Life in JNU taught me how to take many things non-seriously.

I am not sure if JNU shaped my perception in relation to professional life. I have never given it a thought. But JNUites indeed do things 'differently'. I was the only one in my batch

who kissed goodbye to academics. Most others pursued higher education and are teachers in different universities now.

Wafa: Tell us something about your experiences at TCS. What was the trajectory that your career took after you left JNU?

Siddhartha: After completing my Masters in English, I walked out of the campus into the 'real' world to explore what to do next. I needed money to eat, smoke and pay the rent. So I applied for various jobs, mainly in print journalism. Luck did not favour me for months until I applied for the job of a trainee editor at a Tata company, cleared the test and interview and got selected. I have been with the Tatas ever since.

Working in the corporate sector took me to places I used to dream of as a student of literature. The Hermitage in St Petersburg, Rembrandt and Van Gogh museums in Amsterdam, Globe Theatre in London, the Reading jail where Oscar Wilde spent time, Louvre in Paris, Colorado, Sweden, Portugal...

Wafa: Tell us a bit about your debut novel, The Garden of Solitude. What prompted you to write it?

Siddhartha: I remember being a mute witness to the political events that unfolded in Kashmir in 1989. The militancy, the mass uprising, the protests on the streets, the deaths and the devastation! I was in my teens at the time. For years, during the 'peaceful' eighties, certain unrest had been lurking in the hearts and the minds of the Kashmiri people - the Muslims and the Pandits! Muslims were fed up of the hollow promises made by the successive governments in India. There was a life of subjugation, they thought. The Pandits feared that the uprising and the militancy might lead to a 'divide' and that they would be targeted. I saw the bizarre events unfold day after day. While thousands of Kashmiri Muslims came out on the streets, defying curfew and shoot-at-sight orders to protest against India, the Pandits huddled indoors in fear and

bewilderment, not knowing what to do. Many Muslim friends (mostly teenagers) from my neighbourhood joined the freedom movement after undergoing weeks of training across the border. It seemed surreal at first.

Images of the nameless Pandits who fled their homes in the winter of 1990 remained with me. Strangely, the world didn't take notice of the Pandit exodus. The life and plight of the migrants in exile were horrible. People lived in camps (canvas tents) for years. No one cared. The government didle out relief money – a pittance. That was all! Years later, I asked myself a question, 'What am I doing?' I guess there was some torment in me too. Some remnants of memory haunted me. All I did was read books and pine for my homeland endlessly. During the early days of exile, I wrote amateur poetry and short stories. But I was not happy with my writing. I still am not.

Then, one night, I opened a blank document and started typing. It took me weeks to begin. I struggled but I didn't stop. I guess I wanted to narrate a story; an untold story of the exiles. Yet I must admit that I am at best a hobbyist.

Wafa: How much do you resemble Sridar from the novel? And also, what are your plans now as far as writing goes?

Siddhartha: The protagonist of my novel could be the 'other me'. Many people who read my novel commented that they found their small stories in it.

I want to give short fiction a try, but not unless I am convinced that improvements are possible.

Wafa: On a different note, which aspect of JNU did you love the most when you were a student here? Any particular memories that you would like to share?

Siddhartha: Freedom to choose and to do whatever one wants, without shackles and restrictions. It is a world unto itself. Even the most miserable, like me, can survive. Those days one could lead a secret life. I am not sure if this is possible today. The world has changed in the last decade.

Fond memories I will always cherish. I got C minus in a course on Shakespeare because the professor said D plus didn't exist. I got A plus in a course on African Literature because the professor liked the term paper I presented. Pelting stones at Bihar House while protesting the murder of Chandrashekhar, the beloved leader of our student's union! (Real education was protesting against inhumanity.) Another memorable moment was attending Jacques Derrida's lecture in the campus auditorium. Skiing and rafting as part of the mountaineering club activities. Bhang-drenched Holi celebrations.

Wafa: Is there anything in your life which can be dedicated to JNU?

Siddhartha: When I look upon the days I spent in JNU, I feel a sense of nostalgia. JNU proved fruitful in ways more than one. The JNU experience, in particular, shaped my outlook towards life.

Wafa: What message would you like to give to the present JNU student community?

Siddhartha: I don't think I have anything worthwhile to share with JNUites. The last time I was in JNU was when I was packing my bags and preparing to leave. I want to enter the JNU gates and be at the Ganga Dhaba just for a cup of tea and anda-parantha.

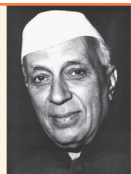
