Sub:- Ongoing Registration in Monsoon Semester 2021-reg.


The academic calendar (PDF attached at Annexure I) for new students seeking admission/registration in Monsoon Semester, 2021 has been modified to the effect that Monsoon Semester 2021 and the Winter Semester 2022 shall stand extended by one month. Accordingly, the duration of the Monsoon Semester, 2021 will be from December, 2021 to April, 2022 and that of the Winter Semester, 2022 will be from May, 2022 to August, 2022.

Further, students of B.A-M.A integrated programme in foreign languages at School of Language, Literature & Cultural Studies, who have completed their B.A and eligible for registration in M.A, will have to get registered by December 31, 2021. Furthermore, continuing students of School of Arts and Aesthetics will have to register for Monsoon Semester, 2021 by December 31, 2021.

The School/Special Centre/Centres need to complete the teaching and evaluation accordingly within the broader framework of the academic calendar (attached).

The academic calendar for continuing students remains unchanged.
