CIRCULAR

In view of unprecedented surge of the COVID-19 cases, and keeping in mind the well-being and safety of students and campus residents, all stakeholders of the University are hereby requested to adhere to the following necessary measures/steps to prevent its spread in the University Campus:

- 1. The JNU Sports Stadium is closed with immediate effect.
- 2. Yoga activities in offline mode are closed with immediate effect; the same may continue in online mode.
- 3. Dining facility in Aravali guest house canteen, as well as other canteens/eateries will be closed with immediate effect; only home delivery and take away would be allowed.
- 4. The operation of Canteens and Dhabas of the Schools/Special Centre/Residential Areas shall be only in take away/home delivery mode. No gathering is permitted in the vicinity.
- 5. The hostel residents are strongly discouraged from visiting other hostels and going out of the campus or to school/centre, unless it is absolutely essential.
- 6. The visitor's movement is allowed only through the North Gate, and other gates shall remain closed till further orders. Residents should avoid non-essential movements inside or outside of the campus and stay safely at home. Also, kindly avoid inviting friends and relatives in the campus.
- 7. Person above 65 years of age, persons with comorbidities, pregnant woman and children below the age of 10 years are advised to stay at home.
- 8. Installation and use of Aarogya Setu App shall be advised to all.
- 9. Campus residents must maintain a minimum distance of 6 feet in public places, even during walking/jogging.
- 10. The shopkeepers and canteen staff are strictly instructed to wear the mask at all the times. Any violation would attract closure of shops/canteens for 2 days initially, and further violation will be dealt strictly as per the guidelines of GOI/Delhi Government/JNU.
- 11. There should be a proper marking at each shop to ensure social distance between customer and vendor & between one customer and another customer.
- 12. Wearing of face mask is mandatory in the campus. The Security Personnel are authorized to take photograph, if anyone is not wearing the face mask. Appropriate disciplinary action including fine shall be imposed in this regard.

- 13. Employees and their family members, and students who are tested positive or under home isolation/quarantine, must inform with supporting document immediately to the Administration/Security.
- 14. These advisories would be applicable with immediate effect and will remain in force until further communication.
