## <u>ORDER</u>

In continuation to the University order and its addendum dated 19.04.2021 regarding CURFEW in the University, all stakeholders of the University are hereby, informed that the Government of National Capital Territory of Delhi, Delhi Disaster Management Authority vide Order No. F.2/07/2020/pt file-III/397 dated 25.04.2021, has extended the CURFEW in the territory of NCT of Delhi from 10.00 P.M. on 26.04.2021 (Monday) to 05.00 A.M. on 03.05.2021 (Monday), except for essential activities/services, as an emergency measures for well-being and safety of people.

In view of above, the curfew will be in force in the University premises from 10.00 P.M. on 26.04.2021 (Monday) to 05.00 A.M. on 03.05.2021 (Monday). However, there shall be no restrictions on movements of persons who are engaged in emergency services, Medical emergency and supply of goods during the curfew period on production of valid I-card. Persons coming from /going to Airport/ Railway station/ISBTs allowed to travel on production of valid ticket. Shops dealing with essential foods, groceries, fruits and vegetables, diary and milk booth, pharmaceuticals and ATM are allowed to function. Whereas, all other shops and school canteens shall be closed during the curfew timings.

Furthermore, the following additional activities shall be allowed during the curfew period, only with the possession of e-pass (in soft or hard copy): (i) Courier Services, (ii) Services provided by self-employed persons- electricians, plumbers, and repairing of water purifiers, (iii) Shops of educational books for students, and (iv) Shops of electric fans.

Due to the curfew announced by the Delhi government, Dr. B.R. Ambedkar Central Library will remain closed strictly from 10.00 A.M. on 26.04.2021 (Monday) to 09.00 A.M. on 03.05.2021 (Monday), till further orders.

The Campus residents are hereby instructed not to move within the campus during the curfew timings. Campus gates will remain closed except for emergency movement. Rest shall remain same as directed in earlier orders dated 19.04.2021.

The Security Branch of the University is instructed to ensure strict compliance of this order, and shall adequately inform and sensitize the field functionaries about these instructions for strict compliance, in letter and spirit and all entry gates of the campus shall be closed in the curfew timings.
