Department of Scientific & Industrial Research(DSIR) MoS&T, GoI had issued the Certificate of Registration dated 23.09.2016 to Jawaharlal Nehru University for purpose of availing Custom Duty exemption with validity upto 31.08.2021.

The university, however, also became eligible to avail exemption under GST on procurement of certain goods listed in relevant notifications. In absence of any certificate from DSIR to this effect, the university has been availing these exemption under GST on the basis of certificate signed by the Director R&D and the Registrar on individual case basis resulting into increased paper work for these dignitaries as well as of the Project Investigators and other procuring officers.

DSIR, on request of the university, has issued a revised Certificate of Registration dated 13.08.2018 incorporating therein the elements of exemption under GST applicable to the university besides availing custom duty exemption in single certificate with validity upto 31.08.2021.

With issue of this certificate by DSIR, the practice of seeking exemption under GST on individual certificate basis has been done away with. All Project Investigators and other procuring officers making procurement on behalf of the university are hereby informed to avail exemption of taxes under GST wherever applicable and as amended from time to time.
