Course Objectives

Latin American foreign policy will be studied in the context of the dynamics of the political systems in the countries concerned as expressed in the power structure and political behavior and the current national policy problems. Attention will be given to major countries in the diverse issues faced by these countries including the Caribbean.

The student is expected to develop a well-balanced thought process and analytical skills to be able to examine different issues of concern and interest in the Latin American region especially with respect to sustainable development, environmental politics, regional groupings, security issues including energy, nuclear and migration. The student should be able to reflect on these issues in the context of the Indian foreign policy perspective.
