Course Objectives

The main focus of the course would be to explain the nature of public health situation in urban India and trace its relationship with the urban economy, distribution of resources and public policy. While doing so, it shall explore the relationship between the nature of urbanisation and public health. It will focus on the issues in public health and their links with (a) nature of urban growth, infrastructural facilities and socio-economic conditions; (b) urban politics and governance (including distribution and utilisation) of infrastructural facilitates and (c) health programmes and health care services both in the public and private sectors.

The course will use social epidemiology and political economy approaches as complementary to each other. Historical account of the relationship between urban growth in Europe and in colonial India and post-independent India; urbanisation, especially in the third world countries will be discussed. Selected cities as case studies will also be discussed. Emerging issues of healthy cities; public policies and climate change will constitute an important segment of the course. Its emphasis would be on perspectives and possible choices.
